

# **AGREEMENT**

For the provision of taxi and transport services.
Concluded on year. Belgrade between:
1 `` Naxi taksi"from Belgrade, Str. Kneza Višeslava 63 bank account 170-30018246000-31, represented by Director: Nenad Glavčić, (Hereinafter referred to as the provider of taxi services) and 2 ", Belgrade, Account number(hereinafter referred to
As user of taxi service)
Article 1
The taxi service provider obligates to provide payment to user of services taxi services by taxi bills.
User of taxi service can use the service "Loyalty card" as payment method to taxi service provider, and as identifying card for company that user of taxi service presents in taxi service provider records. User of taxi service is committed to use "Loyalty card" service accordingly to taxi service provider agreement.
User of taxi service using Loyalty card service, cannot transfer card to third party
User of taxi service will use the services according to the current pricelist and rules as the general public.
Taxi service provider obligates to notify in advance the user for possible price changes.
Article 2
The service provider will provide the user to schedule taxi rides in advance, by phone or by e-mail
and confirmed in writing. In the case of scheduling rides with waiting service at the airport the client will send to the service provider all the data of the passengers, the number of passengers and time of flight.
Article 3
In the taxi bill the customer must enter the following information:
User-Name
-Route on which the service is provided
-The date of the services
The official number-offender services and his signature
-Signature of service user and stamp
Article 4

Taxi bill described in the previous section of the contract is numbered and contains three copies (one original and two copies) of which the first two copies takes over a driver-services provider and the third keeps the customers. The completed taxi bill serves as document on service given and the contractual parties mutually recognized this bill that compiles to a monthly bill.

## Article 5

Service provider will charge, for the complete taxi transport made, by the issuing monthly bill to servi	ce
user, from 1th to 5th in the current month for services rendered in the previous month.

# Article 6

The service user is obliged to pay the bill exposed 30 days from receiving of invoice (invoices).

## Article 7

If the parties cannot amicably resolve any problems arising regarding this Agreement, in charge will be the First Municipal Court in Belgrade.

## Article 8

Agreement shall enter into force upon the day of signing, may be terminated at any time with a prior notice period of 15 days to the other contractual party.

## Article 9

Agreement is made in two (2) identical copies one for each side.
